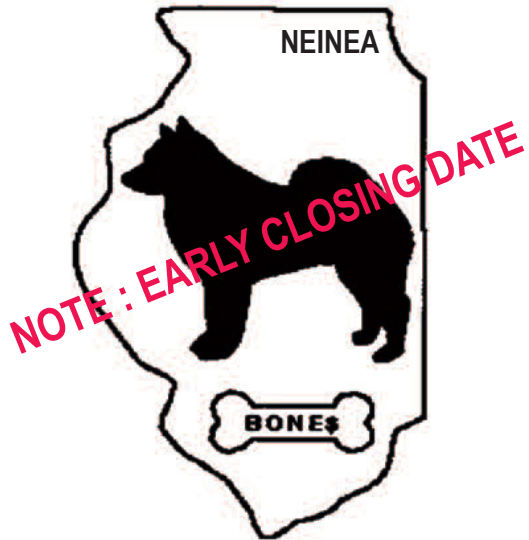

All entry fee checks or money orders (US funds) are to be made payable to CAPER. One check is sufficient for all enclosed entries.

Entries are to be mailed to: **NEINEA/CAPER, 4044 S. 92nd St, Greenfield WI 53228.**

Entries must be received by **6 pm CDT Wed. June 6**, after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club. All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will render the entry invalid; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via cash, certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature. **Entries received without signature release will be refused.**

**Refunds:** Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Show Committee; or in the event that extreme weather conditions, civil disturbances, or other acts beyond the control of the Show Committee make it impossible to open or complete the show/trial. Refunds for bitches in season in obedience, and rally will be given (less \$4/entry), if notification (including veterinary certification) is made to the trial secretary prior to the start of judging for the day.

**Fax/email entries:** Entries may be faxed to the Show/Trial Secretary at 206-222-2830, or emailed to [barb@caper-dogs.com](mailto:barb@caper-dogs.com). Both the front and back of each entry form must be included, completely filled out and signed, or the entry will not be accepted. Payment can be made via PayPal or credit card by going to [www.caper-dogs.com/ContactCAPER.htm](http://www.caper-dogs.com/ContactCAPER.htm) and following the instructions there. **Payment must include the \$2.00 per class additional charge to be valid.**

**Entry Acknowledgements:** To ensure the receipt of your entries, it is suggested that you include a valid email address which you regularly check on your entry form, as that will allow the Secretary to send an email receipt of entry. If you do not have email, send a self-addressed, stamped postcard or envelope with your entry, which the Secretary will return upon entry receipt. Judging programs and entry confirmations will be emailed to each exhibitor as soon as possible after the closing date. If the confirmation is to be sent to a person other than the dog's owner, please include with the entry the name and address or email address to which it is to be sent. **Exhibitors are responsible for the correctness of entries. Any errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Overpayments of less than \$5 will not be refunded.**

**Move Ups to Best of Breed or Open/Master Jr Show classes:** Dogs which, according to their owner's records, have completed the requirements for a championship after the closing of entries for this show may be transferred from the Dog or Bitch class to the Best of Breed class. Similarly, an entrant in a Novice Junior Showmanship can be transferred to Open if the junior has earned a third 1st place, and an Open entry can be moved to Masters if the junior has earned a tenth first place, after this show's closing date. Each of these transfer requests must be made to, and accepted by, the Show Secretary at least 30 minutes prior to the start of any regular conformation judging at this show.

1. Entries will not be accepted without proper fees and signatures. Entries must be submitted on approved entry forms with the signed agreement on the reverse side.
2. Please typewrite or print plainly all information on the entry except the owner's signature.
3. No entries will be returned if the show cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, strikes or any other causes beyond the control of Northeastern Illinois Norwegian Elkhound Assn.
4. Trophies must be claimed at the show. None will be mailed.
5. Exercise dogs in designated areas only. Clean up after your dogs.
6. Entry fees will not be refunded in the event that a dog is absent, disqualified or excused by a Veterinarian or Judge, or barred from competition by action of the Show Committee.
7. No hookups or camping facilities at the Show site.
8. The Fair Grounds will be available after 5:30 p.m. Friday, June 29th, 2018. Building Closes 6:30 pm

## JUNIOR SHOWMANSHIP

**Novice class:** For junior handlers aged 9-17 who, at the time entries close, have not won three first place awards, with competition present, in a Novice Junior Showmanship class at a licensed or member show. The Novice class is divided:

Novice Junior - 9 years and under 12 years on the day of the show;  
Novice Intermediate - 12 years and under 15 years on the day of the show;  
Novice Senior - 15 years and under 18 years on the day of the show.

**Open class:** For junior handlers aged 9-17 who, at the time entries close, have won three first place awards, with competition present, in a Novice Junior Showmanship class at a licensed or member show. The Open class is divided:

Open Junior - 9 years and under 12 years on the day of the show;  
Open Intermediate - 12 years and under 15 years on the day of the show;  
Open Senior - 15 years and under 18 years on the day of the show.

**Master class:** For junior handlers aged 9-17 who, at the time entries close, have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

PLEASE NOTE: Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form.

Dogs shown in Junior Showmanship may have Full or Limited AKC registration or have an ILP/PAL number.

Altered animals are eligible to be shown, but bitches in season are not eligible.

## SWEEPSTAKES (Saturday only)

### Puppy Sweepstakes

Puppy Sweepstakes is open to all Norwegian Elkhounds who on the day of the show, will be 6 months and under 18 months of age, and who have not completed a championship prior to the closing of entries. Each entry for the sweepstakes must be entered in a regular class at this show.

Distribution of Puppy Sweepstakes Prize Money

35% of total entry fees will be retained by Club for expenses. The remainder of the monies received from entry fees shall be awarded to the class winners on a proportional basis as follows: 50% to be divided among first place winners. The remaining 50% of the fee divided 60% to Best Puppy in Sweepstakes and 40% to Best of Opposite Sex to Best Puppy in Sweepstakes.

### Veteran Sweepstakes

Veteran Sweepstakes is open to all Norwegian Elkhounds who are at least 7 years of age on the day of the Sweepstakes. Entrants may be altered and **need not be entered in a regular class**. Only one winner from each class will be chosen. There is no competition between the sexes. From the class winners, a Best Veteran Dog in Sweepstakes and Best Veteran Bitch in Sweepstakes will be chosen.

35% of total entry fees will be retained by Club for expenses. The division of entry fees will be an equal split between Best Dog and Best Bitch in Veteran Sweepstakes. Best Veteran Dog 50% & Best Veteran Bitch 50% A Participatio Ribbon will be awarded to each participant.

All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to Club. Class cash prizes will be paid in the ring to the person handling the dog. Claims for prize money must be made in the ring before the judging is over. The NEINEA & CAPER disclaim any liability for cash prizes after judging is over.

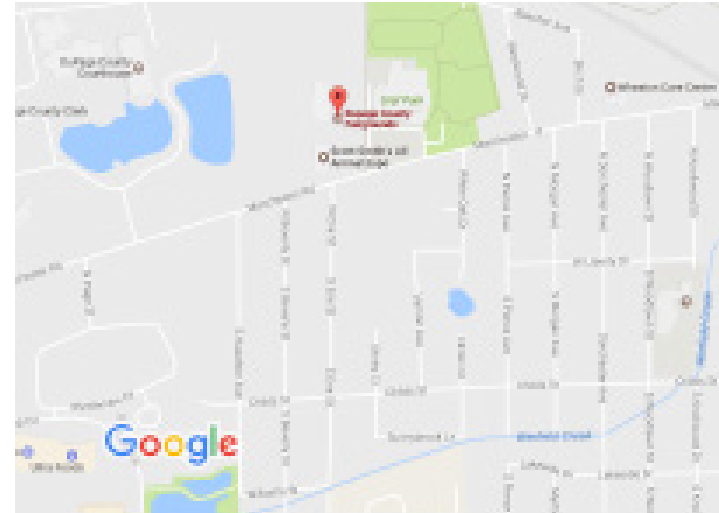
